**The Consultant Firm/ Agency, who meets the following qualifying requirement, shall be eligible for this tender:**

- 1) The bidder shall be a reputed ISO 9001:2015, ISO 27001:2013 and CMMI-3certified Indian company/agency/firm registered in India and shall be in operation for at least 10 years from the date of its function.
- 2) The bidder must have successfully handled and completed minimum 10 (Ten) projects of end-to-end online recruitment / selection process work orders from co-operative organizations/Departments of Central Government, State Government/ during last 5 (Five) Financial Years, out of which minimum 5(Five) work orders from co-operative organizations. The consultant firm/agency should submit the details of such assignments undertaken.

- 3) The bidder must have successfully handled minimum 1 online application project in any of the Departments of Central Government, State Government with a project value of more than Rs.1.00 crore.
- 4) The bidder must have developed their own software which can be customized as per the requirements.
- 5) Average annual turnover for last three years i.e. 2018-19, 2019-20 and 2020- 21 should not be less than Rs. 2.5 crore.
- 6) The bidder or any of its director/s or partner/s should neither be convicted by any court of law nor any criminal case be pending against such concern before court of law. The bidder shall never have been blacklisted/ barred/ disqualified by any Government concern / regulator / statutory body. An undertaking to this effect should be furnished.
- 7) The bidders must possess the registration/ certificate/ license/permit as required under relevant viz: PAN, GST, PP. ESIC, etc as applicable to them.
